

**Regulations of PKO Bank Polski PGA Polska Tour 2026**  
**PRO-AM PGA Polska Race to Rosa 5 July 2026**

**1. The Tournament Committee**

- a. Tournament Director: Martyna Kinda
- b. Head Referee: Piotr Urbański

The Tournament Committee will issue local rules before the start of the tournament. The tournament is played in accordance with the "General Regulations of PGA Poland Tournaments" and Hard Card PGA Poland.

Pro-Am **PGA Polska Race to Rosa** will be played on **5 July 2026** on the golf course of Rosa Golf Club.

**2. Eligible to play**

a. Professionals:

- i. Members of PGA Poland,
- ii. PGA Poland students
- iii. Persons who obtained the permission of the Tournament Director meeting the conditions of the PGA Poland General Tournament Regulations

Professionals in the Pro-Am tournament will play with a playing handicap of 0.

b. Amateurs: all players with valid, active HCP and not having active or current handicap are admitted to the game. Those who do not have a valid, active HCP will play with playing HCP 0. The maximum playing handicap is: 36.

**3. Entries for the tournament**

Teams on ProAm should be notified by e-mail, however, the team's e-mail notification is not synonymous with the registration of the player. Each player is required to register individually via the Golfbox website. Applications are accepted until June 14, 2026 only by filling out the registration form and paying for participation in the tournament by bank transfer to the account provided on the website [www.pgapolska.com](http://www.pgapolska.com).

The limit of amateurs in the tournament is set to 60 players. The order of applications decides, provided that the entry fee is paid within **SEVEN DAYS BEFORE THE TOURNAMENT IS STARTED**

**4. Tournament format**

The team at Pro-Am consists of a minimum of 2, and a maximum of 3 amateurs and 1 PRO. The Pro-Am tournament is played on eighteen holes in the better ball stroke play net format with ½ handicap. The sum of the two best results from each hole counts for the classification.

The tee shot on each hole, except for PAR 3 holes, will be played in the Texas Scramble format – each player hits their own ball from the tee area. After all players have taken their shots, the Pro selects one of the balls (their own or an amateur's), marks its position, and then each player plays their own ball from a spot no farther than the width of a length of a club from the marked position, no closer to the hole. The ball must be placed in the designated area. The player whose ball was selected hits first. After that, each player continues to play their own ball.

Tournament starts on the shotgun or tee off.

Each team must give back two scorecards. Otherwise, the result will not be counted and the team will be disqualified.

## **5. Tee**

a. Professionals:

- i. women up to 55 years old: yellow, 6009 m,
- ii. men up to 55 years old: white, 6465 m,
- iii. Senior women 55 years and older: red, 5254 m,
- iv. Senior men 55 years and older: yellow, 6009m

b. Amateurs:

- i. Women: red, 5254 m, taking into account the length changes allowed by the European Golf Federation (EGA)
- ii. Children: red, 5254 m, taking into account the length changes allowed by the European Golf Federation (EGA),
- iii. men and juniors over 12: yellow 6009 m, taking into account the length changes allowed by the European Golf Federation (EGA)

Amateurs in the Pro-Am Tournament can play a round of tee for professional players, men - white, women - yellow. An amateur who decides to play with a professional tee must report it to the tournament director before the game starts. Changing the tee during the round is forbidden.

## **6. Obligation to play in the Pro-Am tournament**

Presence during the Pro-Am tournament is OBLIGATORY for the first 18 professional players from the PGA Polska Order of Merit list. Players who cannot participate in the Pro-Am tournament will not be admitted to the main event unless they take part in a higher category tournament at this time (eg Challenge Tour, European Tour and satellite tournaments etc.).

## **7. Fees**

Fees are accepted 7 days before the start of the tournament to the bank account provided below. Payment after the set date is associated with a 50% higher fee. PGA Polska members with an unpaid membership fee for the 2025 season will not be admitted to the tournament. In case of resignation from the tournament after the publication of the start lists, the tournament fee will not be refunded.

- a. Club members – 400 pln
- b. Club Guests - 500 pln
- c. Juniors – 350 pln
- d. PRO and Non Am - no fee

A refund of the entry fees paid by players qualified for the tournament will be made only upon submission of a written notice of withdrawal from participation no later than two days before the tournament to the following

address: [biuro@pgapolska.com](mailto:biuro@pgapolska.com). The refund of the paid entry fees will be processed within one month after the conclusion of the tournament.

In the event that the tournament is not held or is interrupted due to reasons beyond the organizer's control, in particular due to adverse weather conditions or force majeure, the tournament fees shall not be refunded.

## **8. Awards**

During the PRO-AM, the best three teams will be awarded.

The failure to award a prize by an amateur is tantamount to its loss. In-kind prizes that will not be collected during the award ceremony will be transferred to an additional competition during the final of the cycle - PGA Polska Championship.

## **9. Draws**

In the case of equal results, the countback will be decisive in the following order: better results on the last 9, 6, 3, 1 holes. The "last 9 holes" is understood as holes 10-18 of the field.

## **10. Personal data**

According to the Polish law art. 13 para. 1 and par. 2 GDPR (General Data Protection Regulation. Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (general regulation on data protection) of April 27, 2016 (Journal of Laws of EU, No. 119), we would like to inform you that:

1. The administrator of personal data of Tournament participants is the Professional Golf Association - PGA Poland with headquarters in Warsaw 00-067, Al. Jerozolimskie 65/79, email [biuro@pgapolska.com](mailto:biuro@pgapolska.com), contact telephone: 506875558
2. Personal data of the Athletes, such as: name, email address, telephone number, provided as part of the registration form will be processed by the Organizer to the extent necessary to conduct the Tournament, in particular in order to complete the application process and confirm the Player's participation in Tournament, announcement of results, distribution of prizes, consideration of possible complaints / claims made in connection with participation in the Tournament.
3. If the Athlete agrees, his personal data, in the areas referred to in point 1, shall also be processed by the Organizer in order to send the Athlete information and commercial information of the Organizer's partners.
4. Each participant of the Tournament agrees to take photographs, free use of the image in the film, photo and audiovisual materials prepared by the Tournament Committee or by an entity authorized by the Tournament Committee. Consent to the free use of the tournament participant's image includes multiple use of the tournament participant's image for promotional, marketing, advertising and publishing purposes.
5. The personal data of the Tournament participants will be used in accordance with the conditions set out in the GDPR Regulation, Polish regulations adopted in order to enable the application of the GDPR, other applicable laws and these Regulations.
6. The controller of personal data does not transmit data to a third country / international organization. Personal data of participants will not be subject to automated processing, including profiling.
7. The basis for the processing of personal data of the Tournament participants is art. 6 par. 1 letter b) GDPR - performance of the contract (acceptance of the Regulations and registration of participation in the Tournament constitutes the conclusion of the contract) and art. 6 par. 1 lit. a) GDPR - voluntary, unambiguous, informed and specific consent of the data subject.
8. Tournament participants have the right to access their data and the right to rectify, delete, limit the processing, the right to data transfer, the right to raise objections, the right to withdraw consent at any time without affecting the legality of processing, which was made on the basis of consent before its withdrawal.

Withdrawal of consent does not affect the lawfulness of the processing that was made on the basis of consent before its withdrawal.

9. Participants of the Tournament have the right to lodge a complaint with the Supervisory Body when the Participant considers that the processing of his personal data violates the provisions of the GDPR.

10. Providing personal data and consenting to their processing is voluntary, but their failure or lack of consent to their processing prevents participation in the Tournament. Making a notification is tantamount to accepting the rules contained in the Regulations of the event and giving consent to the processing of personal data. In the case of a minor, consent to the processing of personal data must be expressed by the person having parental authority or legal guardian.

11. The processing of data in connection with participation in the Tournament includes in particular:

a. reminder about paying a fee for participation in the tournament by phone or email

b. the publication on the website of the PGA Polska Race to Rosa Tournament of the name and surname of the participant on the tournament start list along with the start times

c. the publication on the website of the PGA Polska Race to Rosa Tournament of the name and surname on the tournament score list
